Construction of hostels in Delhi University

Girls hostel at North Campus has already been awarded and Tenders for construction of 100 seated Boys hostel at South Campus of the University have been received. These hostels are expected to be-completed within two years.

Losses of Railways

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS, MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF PLANNING AND **IMPLEMENTATION** PROGRAMME (SHRI RAM NAIK): (a) and (b) In view of the shortfall in loading of core sector commodities such as Coal, Food-grains, Iron and Steel, Cement and Iron Ore, freight earnings have also dropped below the expected level. However, there is some bouyancy in Passenger, Other Coaching and Sundry earnings. With this, the total earnings of the Railways for the current financial year, are being estimated to be short of the target by Rs. 1056 crores.

(c) and (d) Zonal railways have been directed to make special efforts to capture additional freight traffic in core sectors as also in other areas so as to make good the shortfall to the extent possible. The steps taken by Ministry of Railways to attract more traffic, inter alia, include reduction in classification of certain commodities, providing 'Volume Discount' on selected commodities delegating full powers to the General Managers to quote Station-to-Station rates and preparing a special package for Steel sector. Besides, the zonal railways have also been directed to enhance passenger earnings, intensify ticket checking, pursue recovery of outstanding dues and also control Ordinary Working Expenses.

Laying of double line on Ghaziabad-Moradabad route
