Reconstitution of Lalit Kala Academy 1190. DR. C. NARAYANA REDDY: Will the Minister of HUMAN RE-SOURCE DEVELOPMENT be pleased to state:

- (a) whether Government are considering reconstituting the Lalit Kala Academy; and
- (b) if so, by when it is likely to be taken up?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT MURLI MANOHAR JOSHI): (a) and (b) The Government of India on the basis of the Haksar Committee recommendations has approved amendments to the Memorandum of Association and Rules and Regulations of Lalit Kala Academy and has notified the revised Memorandum of Association and Rules and Regulations on 8.1.1999. The General Council of the Akademi is being reconstituted as per the provisions contained in the revised Memorandum of Assoication and Rules and Regulations. Instructions have been issued to the Administrator-LKA to conduct elections to the artists constituency of the General Council. The whole process of reconstitution of the General Council of the Lalit Kala Academy is likely to be completed by the end of April, 1999. Thereafter, the Government intends to hand over the management of the Academy to the new General Council.

Computers in KVs and Navyug Schools

Fake Admissions in Delhi University
