Delhi Development Act, Delhi Municipal Corporation Act, New Delhi Municipal Council Act and the Public Premises (Eviction of Unauthorised Occupants) Act is taken by the concerned departments/agencies.

problem  $T_{\Omega}$ tackle the encroachment/unauthorised construction, the Government have been emphasising from time to time the need to take action against such unauthorised construction and to protect public land from encroachment at the initial stage itself, launch criminal trespass cases against encroachers and take action against the delinquent staff, charged with the responsibility of watch and ward of such lands. Instructions have also been issued to the land owning agencies, local bodies and DDA to this effect.

## Conversion of Property from Leasehold to Freehold

1390. SHRI P. PRABHAKAR REDDY: Will the Minister of URBAN AFFAIRS AND EMPLOYMENT be pleased to state:

- (a) whether Government have any proposal under consideration to allow conversion of property from leasehold to freehold on the basis of land rates prevalent in 1987;

(c) The present scheme covers the flats constructed by Cooperative Group Housing Societies including Multi

Storeyed flats on land leased by the Delhi Development Authority.
