Janata Cloth Scheme

2476. DR. C. NARAYANA REDDY: Will the Minister of TEXTILES be pleased to state:

(a) whether it is a fact that Janata Cloth Scheme, which was introduced with the objective to provide sustained income to handloom weavers, has been totally phased out;

(b) if so, the reasons therefor; and

(c) what steps have been taken by Government to provide adequate protection and support to unskilled handloom weavers?

THE MINISTER OF TEXTILES (SHRI KASHIRAM RANA): (a) and (b) Yes, Sir. A committee constituted in 1991 to review the Janata Cloth Scheme recommended its phasing out, since it had contributed to the de-skilling of the weavers.

It was decided by the Government to introduce a modified Janata Cloth Scheme w.e.f. 1993-94 for the 8th Plan period. The Scheme was however, extended during 1997-98 to facilitate transition.

(c) Consequent to phasing out of the Janata Cloth Scheme by the end of the 8th Plan period, the Government introduced two major developmental schemes. Viz., the Project Package Scheme (PPS) during 1991-92 and Handloom Development Centre (HDC) Scheme during 1993-94, to provide financial support to weavers in a integrated and coordinated manner which also included skill upgradation of de-skilled handloom weavers.
