Students in National School of Drama

2884. SHRI GANDHI AZAD: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) the total number of students admitted in National School of Drama during the last three years, year-wise;

(b) the number of SC/ST candidates who applied for and were admitted in the National School of Drama during last three years, year-wise;

(c) the number of reserved seats converted into general category during above period, year-wise indicating the detailed reasons; and

(d) the reasons for not filling the reserved vacancies in NSD repertory?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) to (c) The National School of Drama Admits 20 students annually. The selection criterion is talent. Four seats out of 20 are reserved for SC/ST. In the admission notice itself the School makes it clear that if no suitable candidate is available for admission from the reserved category, the seats will be offered to general category candidates. A statement showing the number of SC/ST candidate applied and finally selected for admission during the last three years is as follows:

(d) For the National School of Drama Repertory, artists are appointed on contractual basis and therefore, there is no reservation in posts.

Money for Mid-day Meal Scheme

2885. SHRI SANATAN BISI: Will the MINISTER OF HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it is a fact that money allocated for mid-day meal scheme is just not adequate;

(b) what is the actual requirement;

(c) whether it is a fact that in the past the FCI had not released the required foodgrains to all the States due to delayed payments; and

(d) if so, what are the details thereof?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) Yes, Sir.

(b) Based on the enrolment data supplied by the States/UTs, the estimated requirement of funds in-1998-99 was Rs. 2700 crores against which a final grant of Rs. 1600.15 crore has been provided.

(c) and (d) Yes, Sir. During July to September 1998, the supply of foodgrains by FCI had been temporarily suspended in State/UTs due to problems relating to the reconciliation of lifting figures* and non-release of funds to FCI. Supply of foodgrains was resumed from October, 1998 on payment of FCI's dues.

धोलावीरा में प्राचीन अवशेषों का संरक्षण

(क) भारतीय पुरात्व सर्वेक्षण क्षरा स्मारकों के संरक्षण और रख-रखाव के बारे में अद्यतन ब्यौरा क्या है,

(ख) क्या उनके द्वारा कच्छ के धोलावीरा में स्थित प्राचीन अवशेषों के संरक्षण हेतु कोई विस्तृत योजना बनाई गई है,

(ग) इस प्रयोजनार्थ वर्षवार कितनी राशि खर्च की जा रही है,

(घ) क्या भारती पुरातत्व सर्वेक्षण ने धोलावीरा के विकास औ संरक्षण के लिए अतिरिक्त वित्तीय सहायता की मांग की है, और

(ङ) क्या रख-रखाव संबंधित योजना को उनके द्वारा अंतिम रूप दे दिया गया है ?

मानव संसाधन विकास मंत्री (डा० मुरली मनोहर जोशी) : (क) केन्द्र द्वारा संरक्षित स्मारकों को रखरखाव एवं संरक्षण पुरातत्वीय मानकों एवं सिद्धांतों के अनुसार किया जाता है,

(ख) गुजरात के जिला कच्छ में धोलावीरा के उत्खनित हड़प्पाकालीन अवशेषों, जिनमें एक किला, एक मध्यवर्ती नगर, एक निचला नगर, दो स्टेडियम एक जलाशयों की श्रृंखला एवं भीतरी किलाबंदी तथा एक कब्रिस्तान आदि शामिल हैं, का संरक्षण फंड की उपलब्धता के अधीन एक सतत प्रक्रिया है ।

(ग) इस परिसर के संरक्षण कार्यों पर किया गया व्यय निम्न प्रकार है :-

1996-97	1.50 लाख रुपये
1997-98	3.33 लाख रुपये
1998-99	3.29 लाख रुपये

चालू-वर्ष के लिए 9.50 लाख रुपये का आबंटन किया गया है ।

(घ) और (ङ) भारतीय पुरातत्व सर्वेक्षण ने पर्यटन से संबंधित के लिए एक समन्वित एवं व्यापक कार्यक्रम तैयार करने का निर्णय लिया है ।

गुजरात सरकार ने अध्ययन के लिए परामर्शी सेवाएं किराए पर ली हैं । उनकी रिपोर्टों के आधार पर फंडों की उपलब्धता के अधीन विशिष्ट परियोजनाओं के कार्यान्वयन पर विचार किया जाएगा ।
