Progress made on Indo-Sri Lanka Trade Pact

2968. SHRI RAMDAS AGARWAL: Will the Minister of COMMERCE be pleased to state:

- (a) whether Government's attention has been drawn to a newsitem published in the Hindustan Times dated 12th March, 1999 captioned "No forward movement yet on Indo-Sri Lanka Trade Pact";
- (b) if so, the hindrances coming in the way of implementation of above agreement between the two countries; and
- (c) by when Government would be able to set out the differences indicating whether this matter figured during the Foreign Ministers' meeting of SAARC countries held in Sri Lanka?

THE MINISTER OF COMMERCE (SHRI RAMAKRISHNA HEDGE): (a) Yes, Sir.

(b) and (c) The lists of items on which duty preferences shall be given, and those on which no preferences shall be given by the two sides for the present, are under finalisation. Consultations are on for the purpose. The matter also figured in the discussions during Foreign Minsters' visit to Sri Lanka recently. The matter is expected to be finalised shortly.
