## World Bank aid for Cleansing Yamuna

2809. SHRIMATI VEENA VARMA: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) whether there is a plan for cleansing the Yamuna and preventing further pollution of Yamuna waters, in and around the capital with World Bank aid:
- (b) if so, the details of the scheme, its cost and the World Bank aid expected therefor; and
- (c) what steps have been taken so far for cleansing the Yamuna?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI BABU LAL MARANDI): (a) No plan for cleansing the Yamuna and for preventing the further pollution of Yamuna waters with World Bank aid in and around the capital is under consideration.

- (b) Does not arise.
- (c) The Yamuna Action Plan was launched in April, 1993. Under this Plan, a capacity to treat 745 million litres per day of sewage will be created. The plan is in various stages of progress. Schemes have been sanctioned for a sum of Rs. 451.47 crores in the States of Uttar Pradesh. Harvana and Delhi. Schemes sanctioned include (1) interception and diversion works (2) sewage treatment plants (3) low cost sanitation (4) river front development works (5) afforestation - and construction of crematoria. Two sewage treatment plants and an electric

crematorium have been taken up in Delhi under the Plan. In addition, the Government of the National Capital Territory of Delhi under its own plan is constructing sewage treatment plants with appurtenant works at an approved cost of Rs. 469.67 crores. All these plants, except one will be completed by December, 1999. The remaining sewage treatment plant is targeted for completion by June, 2000.
