(c) and (f) IDR Act docs not override SICA 1985. As reported to Parliament in the Annual Report of the Ministry of Industry for the year 1996-97, the policy of the Govt, of India is not to take over any sick units under the provisions of IDR Act.

Indo-Myanmar Trade treaty

- *400. SHRI W. ANGOU SINGH: Will the Minister of COMMERCE be pleased to state:
- (a) whether Government have monitored the Indo-Myanmar Trade treaty at Moreh, the border town, of Manipur;
- (b) if so, the steps taken by Government for improving the present problems now in the area on Indian side; and
- (c) whether Government have proposals to make trade treaty in the border area with Myanmar and Bangladesh?

THE MINISTER OF COMMERCE (SHRI RAMAKRISHNA HEGDE): (a) Yes, Sir.

- (b) Government of India have taken several steps for improving the Indo-Myanmar trade which include;
 - (i) Periodical review of Indo-Myanmar trade is being held at Government level talks. The last such review was done in October, 1998 at Yangon in Myanmar.
 - (ii) Myanmar Government have been requested to approve the draft of a Memorandum of Understanding proposed by India on inter-banking arrangements at Moreh-Tamu border point. It was also suggested by India during the Government level meeting in October, 1998, that pending inter-banking arrangements at Moreh-Tamu border point, demand drafts could be accepted for transactions upto US\$ 10,000 and Myanmar side had noted it for consideration. It was agreed that

for transactions above this amount, Letter of Credit would have to be opened.

- (iii) The Exim Policy has exempted persons importing and exporting goods from/to Myanmar through the border from the requirement of having Importer-Exporter Code number provided the CIF value of single consignment does not exceed Rs. 25,000/-No. GR (Guaranteed Remittance) formalities are required to be completed for border trade transactions upto US\$ 1000.
- (iv) The Tamu-Kalemyo road in Myanmar is being upgraded Government of India to facilitate the promotion of border trade between the two countries.
- (v) Myanmar Government have been expedite requested to operationalisation of the second border point at. Champai in India and Rhi in Myanmar. On the Indian side, a township is being developed at Zokhawthar near Champai in Mizoram.
- Indo-Myanmar Border Trade Agreement has already been signed on 21.1.1994.

Government of India and Government of Bangladesh have agreed to set up a Group of Experts of examine and recommendations on all relevant aspects of opening of border trade between the two countries.
