scheme is not applicable to Ahmedabad City.

(c) and (d) A request was received from the Government of Gujarat to include Ahmedabad under the Centrally Sponsored Scheme for Infrastructural Development in Mega Cities. As already mentioned in reply to pasrts (a) and (b) above, Ahmedabad does not fulfill the basic criterion of 4.00 million population as per 1991 census and, therefore, the scheme is not applicable to Ahmedabd City.

Rally by CPWD Engineer's Association

THE MINISTER OF STATE IN THE MINISTRY OF URBAN AFFAIRS **EMPLOYMENT** (SHRI BHANDARU DATTATREYA): (a) The CPWD Engineers Association and CPWD Junior Engineers Association had held mass rally at Nirman Bhawan from 9th to 11th March, 1999.

- (b) The main demands reaised by the Association were:
 - (i) Grant of Planning / Designing allowance to AEs and JEs; and
 - (ii) removal of anomaly in the pay scale of Assistant Engineers and Junior Engineers.

- (c) The present position of these demands are as under:
 - (i) While the Vth Pay Commission had recomended grant of Planning Designing allowance to JEs and AEs posted in the Central Design Organisation in the Headquarters. CPWD have proposed grant of such allowances persons to deployed on planning and designing work in the divisions, circles, and zones as well, which is under consideration of the Government.
 - (ii) The proposal for grant of pay scale of Rs. 7,500-12,000/- to all the Assistant Engineers instead of 50% posts as recommended by the Vth Pav Commission is under consideration. The other demand for removal of the socalled anomaly in the pay scale of Junior Engineers has been considered and rejected.
