- (iii) Social Security Pension to eligible persons.
- (iv) Indira Awaas to each family.
- (v) Ten thousand rupees to each injured person.
- (vi) Free ration (100 kg. rice, pulses, mustard oil/kerosene oil) to each of the affected families:
- (vii) Blanket/dhotis/saris to each member of the affected families.

The relief granted by the State Government in the case of the Narainpur carnage is as follows:

- One lakh twenty thousand rupees as ex-gratia grant to the dependent of each deceased.
- Ten thousand rupees under the Family Benefit Scheme to eligible next of kin.
- (iii) Social Security Pension to eligible persons.
- (iv) Free ration (100 kg. rice, pulses, mustard oil/kerosene, etc.) to each of the affected families.
- (v) Blankets/Dhotis/Saris to each member of the affected families.
