## Test Agni Missile

- 344. SHRIMATI VEENA VERMA: Will the Minister of DEFENCE be pleased to state:
- (a) whether after the successful fourth round of talks with US-Deputy Secretary of State Mr. Talbot, Government had decided to test the modified longer range version of Angi (IRBM); and
- (b) if so, the main features of the modified version and the results of the test?

THE MINISTER OF DEFENCE (SHRI GEORGE FERNANDES): (a) perception, Based the threat Government had already approved development of a longer range Angi using the state-of-the-art technology developed indigenously. The talks with USA and other interlocutors, during which India have explained to them her security concenrs, have not let to any change in the plan of Agni Progarmme.

(a) whether Director-General (Cantonments) had sought the opinion of Cantonment Board, Agra to dispose of Shakti Nagar Colony quarters to its occupants and a resolution No. VI, dated 30-9-1989 amended on 20-12-1989 was passed by

- the Cantonment Board, Agra to sell these quarters to their present occupants;
- (b) whether an assessment of around Rs. one lakh has been made as the estimated cost for the disposal of each flat, if so, the details thereof; and
- (c) if not, the estimated cost likely to be fixed for the disposal of each flat of the Shakti Nagar Colony quarters?

THE MINISTER OF DEFENCE (SHRI GEORGE FERNANDES): (a) to (c) Yes, Sir. A proposal from Director General Defence Estates for disposal of Shakti Nagar Colony quarter is under consideration of the Government.

The question of assessment of cost of each flat will arise only in case Government decides to dispose of these flats.
