(a) whether it is a fact that no train for Katihar is available at Patna during the day, whereas the Members of Parliament coming from Delhi to Patna by Air have to wait at Patna for about ten hrs. to catch train for Katihar at night;

(b) if so, whether Government propose to introduce a new train from Patna to Katihar during the day, connecting flight at Patna; and

(c) if so, by when and if not, what alternative arrangement is proposed to provide

day train facility to passengers going to Katihar?

However, 5645 Dadar-Guwahati Express (bi-weekly) is providing a day time service between Patna and Katihar.

(b) No, Sir.

(c) There are five pairs of trains serving Patna-Katihar sector adequately. Introduction of a day time train between Patna and Katihar is not feasible at present due to operational and secource constraints.
