(ख) केन्द्रीय माध्यमिक शिक्षा बोर्ड परीक्षा परिणामों की घोषणा होने के पश्चात् उत्तर पुस्तिकाओं के पुनर्मूल्यांकन की अनुमति नहीं प्रदान करता है। किन्तु केन्द्रीय माध्यमिक शिक्षा बोर्ड के परीक्षा उपनियमों में अन्तर्निहित प्रावधानों के अनुसार, वर्ष 1995-96, 1996-97 तथा 1997-98 में 10वीं तथा 12वीं कक्षा की हुई परीक्षाओं के परीक्षा परिणामों की घोषणा होने के बाद इस बोर्ड को अंकों की पुष्टि करने के लिए निम्नलिखित आवेदन प्राप्त हुए थे।

#### **Educating the Children in Indian Culture by the Parents**

726. SHRI E. BALANANDAN: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether parents in the country are not doing what is necessary to educate their children in Indian culture; and

(b) if so, how Government propose to correct the shortcomings of Indian parents?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) and (b) Parents are important stakeholders in the educational system. The National Policy on Education, 1986 (as revised in 1992) enshrines the importance of culture, values and aesthetic appreciation in the educational process. Parents

have a crucial role to play in this connection. A Committee to spell-out Fundamental Duties which will, inter-alia, cover this area has been set up in the Department of Education.

#### **Declaring Darjeeling Himalayan Rail as 'Heritage Train'**

737. SHRI DAWA LAMA: Will the Minister of RAILWAYS be pleased to state:

(a) whether Government would declare the 'Darjeeling Himalayan Rail' connecting New Jalpaiguri and Darjeeling as 'Heritage Train';

(b) whether Government would also agree to lease the railway lands on this stretch, where local people are residing for years; and

(c) whether Government would also agree to allow the local people to use vacant stalls and sheds on this section, on lease or rental basis?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS, MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION (SHRI RAM NAIK): (a) An application has been made to UNESCO for declaring Darjeeling Himalayan Railway as a world heritage site.

(b) No, Sir.

(c) Local people are eligible to apply as and when applications are invited by the railway administration.
