ST Status to 'Argon Muslim' of Ladakh

The filling up of vacancies including reserved vacancies & backlog is done by this Ministry on receiving suitable nominations from Department of Personnal and Training out of the candidates qualifying different exams conducted by UPSC/SSC. All relevant Government instructions are followed while intimating the backlog vacancies & making appointments against backlog.
