- (b) and (c) The loan portion of Self Urban Micro Enterprises (SUME) of earlier Nehru Rozgar Yojana is provided by Commercial Banks. Some States have reported that due to apprehension of poor recovery position the banks are not always coming forward for providing loans to the intended beneficiaries. Froir time to time Government has taken up the matter' with the Reserve Bank of India for advising the Commercial Banks to cooperate with the implementing agencies for sanctioning projects.

Repeal of Urban Land Ceiling **Regulation Act**

- 928. SHRI K.M. KHAN: Will the Minister of URBAN AFFAIRS AND EMPLOYMENT be pleased to state:
- (a) whether Government have ap proved repeal of the Urban Land Ceiling Regulation Act;
 - (b) if so, the details thereof;
- (c) whether the move will ensure a house for each family and benefit the common man in the country; and
- (d) if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN AFFAIRS AND EMPLOYMENT (SHRI BANDARU DATTATREYA): (a) and (b) The Government have decided to repeal Urban Land (Ceiling and Regulation) Act, 1976. The Act will stand repealed after completion of the prescribed legislative process and other related formalities. The Urban Land (Ceiling & Regulation) Repeat Bill, 1988 was, therefore, introduced in the Lok Sabha on 11.6.98. The Bill have now, been referred to the Parliamentary Standing Committee on Urban and Rural Development, for examination and report. The Committee has invited views from experts/interested parties/organisations and individuals in order to examine the Bill.

(c) and (d) The proposed repeal of the Act, alongwith some other incentives and simplification of administrative pro- cedures is expected to revive the stagnant housing industry and provide affordable accommodation. There will be speedy growth in the housing sector and investment will be attracted for housing and other infrastructure sectors.
