नागर विमानन मंत्री(श्री अनंत कुमार): (क) से (ग) बिहार में बोध गया एक प्रसिद्ध तीर्थ स्थल है जो विशेष रूप से भारत और दूसरे देशों में रहने वाले बौद्धमत के अनुयायियों के लिए आकर्षण का केन्द्र हैं। गया विमानपत्तन 50 सीटों वाले टबों-प्राप विमानों के प्रचालनार्थ उपयुक्त हैं। अभी तक किसी भी विमान कंपनी ने गया विमानपत्तन के लिए दैनिक उड़ानें प्रचालित करने के संबंध में अपनी रूचि नहीं जताई हैं,अतः भारतीय विमानपत्तन प्राधिकरण की इस विमानपत्तन के विकास संबंध कोई तात्कालिक योजना नहीं है।

Settlement of Cases of Air Corporations SOST Employees Association

- (a) the number of issues represented by the Air Corporations SOST Employees Association which have been settled in the years 1997 and 1998;
- (b) the number of issues still pending and the reasons for their non-settlement; and

THE MINISTER OF-CIVIL AVIATION (SHRI ANANTH KUMAR): (a) to (c) A total of 127 issues pertaining to Air India, Indian Airlines and Alliance Air were raised by the Air Corporations SOST Employees Association. Out of these, 113 issues have been settled. The remaining issues relate of Promotion, Housing Loans, Transfers, Harassment

etc. Settlement of these issues is an on going process. The concerned organisations have been advised to settle the pending issues at the earliest.

Productivity Linked Incentive scheme in Indian Airlines

- (a) whether the productivity linked incentive scheme has been introduced in Indian Airlines in respect of employees covered by Air Corporation Employees Union and if so, from what date;
- (b) the amount of incentive paid to the employees in terms of percentage of wages under the scheme applicable to employees covered by Air Corporations Employees Union; and
- (c) whether there is any dispute regarding the payment of productivity linked incentive scheme in respect of employees covered by Air Corporations Employees Union and if so, the details thereof?

THE MINISTER OF CIVIL AVIATION (SHRI ANANTH KUMAR): (a) Yes Sir. Productivity Linked Incentive Scheme is in force for the employees covered by the Air Corporations Employees Union (ACEU) w.e.f. 1.1.1995.

- (b) The amount of incentive which is dependent on the actual performance against various parameters such as number of passengers carried, on-time performance etc., vary from month to month. There is no fixed percentage.
