## Approval to Tripura Government for Increasing Market Borrowings

1018. SHRI KHAGEN DAS: Will the Minister of FINANCE be pleased to state:

- (a) whether Government of Tripura has got the approval of the Central Government for increasing market borrowings during 1998-99;

THE MINISTER OF FINANCE (SHRI YASHWANT SINHA): (a) to (c) The level of net market borrowings allocated to Tripura for the year 1998-99 was Rs. 60.00 crores. Taking into account repayments, the gross market borrowing requirement worked out to Rs. 67.43 crores. This amount has since been raised by the Government of Tripura, to which, Government of India have consent under Article 293(3) of the Constitution of India.
