Development Programme (IRDP) Training of Rural Youth for Self-Employment (TRYSEM), Development of Women and Children in Rural Areas (DWCRA), are the major employment schemes being implemented in rural areas of the country. The women and minorities are covered under these schemes.

The Village Panchayats are also empowered to spend up to 10% of funds on maintenance assets created under JRY. Village
