- (d) and (e) In order to contain oil import bill, steps are being taken to increase crude oil production in the country through application of improved technologies, better understanding of reservior behaviour, development of new fields, additional development of existing fields and by inviting foreign and private capital in the upstream sector. The refining capacity is also being increased in the country by expansion of existing refineries in the public sector and setting up of refineries in joint sector and private sector to minimise the product imports.

#### Reduction in Diesel Price

# Petrol and Diesel Outlets in Remote and Rural Areas

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR) (a) Yes, Sir. 252 new retail outlets have been included in the approved RO Marketing Plan 1996-97 for Indian Oil Corporation and AOD.

- (b) No, Sir. IOC has been taking planned initiative and revising and improving its marketing strategy from time to
- (c) and (d) In line with the existing policy, retail outlets are being developed in remote and rural areas after carrying out feasibility study. Locations meeting

volume/distance norms are included in the marketing plan and are developed. This is an ongoing and continuous process. Accordingly, based on the above criteria, Indian Oil Corporation and its Assam Oil Division (AOD), as on 1.10.1998, are having 6801 retail outlet dealerships all over the country including the rural areas.

# LPG Agencies in Chittoor and Cuddapah of Andhra pradesh

Selection process has been set in motion with the constitution of three Dealer Selection Boards for Andhra Pradesh. With the commissioning of the LPG distributorships, the demand of the area will be met adequately.
