

facilities for operation of international flights and making it as a regional hub for operating regular and charter flights to various airports. Further recommendations include construction of new Airports at Tura, Lengpui, improvement of airports at Agartala, Dibrugarh, Lilabari, Silchar, Dimapur and Umroi Airport and development of specific highways in the region.

The Ministry of Tourism has prioritised 77 tourism projects amounting to Rs. 1603 lakhs for Central Financial Assistance during 1998-99 after discussions with the respective State Governments of North Eastern Region. The special projects identified for assistance during the year are: (a) Tourist Village Chumu ke dema, Nagaland, (b) Eco-Tourism Resort at Majoli, Assam, and (c) Development of Menchuka, Arunachal Pradesh as special Tourism Area.

(d) In order to attract private investment in the Tourism Sector in the region, Ministry of Tourism has identified Shillong, Guwahati, Kaziranga, Tawang as a Travel Circuit for the purpose of providing interest subsidy at enhanced rate of 5%.

Crimes on running trains

*151. SHRIMATI KAMLA SINHA:
PROF. A. LAKSHMI SAGAR:

Will the Minister of HOME AFFAIRS be pleased to state:

(a) the number and nature of crimes committed on the running trains since the beginning of 1998 and the Zones which have shown increasing trend; and

(b) the measures taken by Government to check the growing crimes on the running trains and to provide safety to life and property of the passengers?

THE MINISTER OF HOME AFFAIRS (SHRI L.K. ADVANI): (a) and (b) Available information in regard to crimes in running trains during January to October, 1998 is given below:—

(i) Robberies	169
(ii) Dacoities	62
(iii) Murders	17

There were also some cases of theft of mail in trains. The figures of crimes in running trains are not maintained Railway Zone-wise at the Central level.

The registration, investigation, detection and prevention of crimes in running trains is the responsibility of the Government Railway Police. (GRP), which functions under the control of the respective State Governments. The Central Government has been advising the State Governments, from time to time, to take neces-
