1158. MISS FRIDA TOPNO: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that the Civilian Group 'D' staff serving in Delhi Police are not given any promotion during their entire service carrier;
 - (b) if so, the reasons therefor; and
- (c) whether Government propose to review the service conditions of these employees to provide for suitable promotion avenues'?

THE MINISTER OF HOME AFFAIRS (SHRI L. K. ADVANI): (a) and (b) The Civilian Group 'D' staff in Delhi Police, excepting those in the category of "Sweeper" and "Daftari" do not at present have any promotional avenue as there are no higher posts in direct line of promotion available to them.

(c) There is no such proposal under the consideration of the Government at present.
