THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRI OMAK APANG): (a) and (b) With a view to develop tourism, ITDC have decided to construct new hotels at Chandigarh and Anandpursahib. As regards disinvestment of ITDC, no decision has so far been taken by the Government.

(c) The measures taken by ITDC to check declining trend of profitability include *inter alia* enhanced emphasis on product improvement; aggressive marketing plan; training/motivation of manpower, periodical review of performance at Corporate/Ministry level and cost control by exercising economy in expenditure.

(b) The Foreign Exchange Earnings from Tourism during 1997-98 were Rs. 11032.69 crores.

(b) To develop tourism in the North Eastern region, Ministry of Tourism has extended Central financial assistance during 1997-98 as per details given below:

कैलाश-मानसरोवर मार्ग

1236. श्री कुशोक नवांग चम्बा स्तनजिन : क्या पर्यटन मंत्री यह बताने की कृपा करेंगे कि :

- (क) क्या लद्दाख के लोगों ने कैलाश-मानसरोवर मार्ग को वहां से खोलने के लिए कई बार सरकार से अनुरोध किया हैं,
- (ख) क्या देनचोक से यह मार्ग न केवल आसान और सुरक्षित हैं बल्कि कैलाश तक की दूरी दो या तीन दिन में तय की जा सकती हैं. और
- (ग) सरकार द्वारा इस संबंध में अब तक उठाए गए ठोस कदमों का ब्यौरा क्या हैं ?

पर्यटन मंत्रालय में राज्य मंत्री (श्री ओमाक अपांग): (क) से (ग) कैलाश मानसरोवर यात्रा की बढ़ती हुई लोकप्रियता, इसके वर्तमान मार्ग में आने वाली बाधाओं और सीमा के क्षेत्रों, विशेष रूप से लद्दाख के निवासियों के अनुरोध पर इस यात्रा के लिए एक विकल्प मार्ग बनाए जाने की संभावना वर्ष 1992 से विचाराधीन हैं। इस अविध के दौरान चीन की ओर से काफी सुझाव रखे गए। वर्ष 1993 में यह प्रस्ताव किया गया कि एक विकल्प मार्ग, हिमाचल प्रदेश में शिमकी

ला से हो कर खोला जा सकता हैं और वर्ष 1994 से लद्दाख, जम्म व कश्मीर से हो कर डेमचोक मार्ग का भी प्रस्ताव किया गया हैं। चीन वालों ने दशार्या हैं कि विकल्प मार्गों के लिए हमारे प्रस्ताव तिब्बती स्वायत्त क्षेत्रों (टी० ए० आर०) में स्थानीय प्राधिकारियों के विचाराधीन हैं। उन्होंने, जमीन पर नए मार्ग खोलने में परेशानी बताई हैं क्योंकि इसमें, मैदानी इलाकों में खराब सड़क अवस्था और आवास व संचार हेतू उचित आधारित संरचना के अभाव में काफी लम्बी दरी तय करनी शामिल हैं । उन्होंने यह भी बताया कि इन दूरवर्ती क्षेत्रों में आधारित संरचना का विकास करना कोई आसान कार्य नहीं हैं और विकल्प मार्गों के लिए स्विधाओं का निर्माण करने में बहुत समय लग सकता हैं । भारत की तरफ से डेमचोक (लद्दाख) से मार्ग के बारे में भी चीनी प्राधिकारियों ने बताया कि कैलाश मानसरोवर की ओर जाने वाला चीनी मार्ग एक मिलिटरी मार्ग हैं और इसे तीर्थ यात्रियों के लिए खोला जाना मुश्किल हैं।

Issue of Liberal Visas to Foreign Tourists

- SATISHCHANDRA SHRI SITARAM PRADHAN: Will the Minister of TOURISM be pleased to state:
- (a) whether Government have taken various fresh initiatives, policy decisions including system reforms in issue of liberal visas to the visiting foreign tourists to develop and promote tourism industry;
- (b) if so, the details thereof, alongwith proposals under consideration;
- (c) the details of action plan finalised for the current year and Nith Plan period for tourists destinations and likely impact thereof;
- (d) the details of proposals cleared pending for Maharashtra?

THE MINISTER OF STATE IN THE MINISTRY Of TOURISM (SHRI

OMAK APANG): (a) and (b) Govern-meia of India follows libera) policy regarding grant of visa to foreign ""tourists. All Indian Missioins abroad have been delegated powers to issue six months multiple entry visa to foreign tourists. Generally such visas are issued' on the same day Ten Years Tourist visa for U.S. national only has also been introduced recently on reciprocal basis with

the stipulation that stay during each visit shall not exceed 180 days.

(c) and (d) Development of Tourism is primarily the responsibility of the State Governments, However, on the specific request of the State Government of Maharashtra, the Ministry of Tourism has sanctioned Rs 169.84 lakhs for 12 projects in 1997-98. During the current financial year, 10 projects have been prioritised for Maharashtra. No proposal is pending clearance in the Ministry of Tourism.

Computerised link between Darjecling-Kalimpong-Kurscon Siliguri

- 1238. SHRI DAWA LAMA: Will the Minister of TOURISM be pleased to state:
- (a) whether it is a fact that there is no computerised link between Darjeeling-Kalimpong-Kurseong and Siliguri as a result of which tourists are facing problems in reservations;
- (b) whether it is also a fact that for want of computerised network foreign tourists are facing problems to reserve accommodations in advance; and
- (c) the action proposed by Government to solve the problem for promotion of tourism?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRI OMAK APANG): (a) Computerised reservation facilities are already available at Siliguri and provision of such facilities at Darjeeling will be considered by the Ministry of Railways for inclusion in the Annual Plan 1999-2000 subject to feasibility and availability of fundsfresources. Computerised reservation facilities are capital intensive and also necessitate significant recurring costs. The reservation workload at Kalimpong and Kurseong is not of sufficiently high order to warrant this level of investment at present.

(b) and (c). A project has been undertaken for networking of the five systems of Calcutta, Mumbai, Chennai, Delhi and Secunderabad. The software for networking has already been developed. The first
