## **Privatisation of Postal Services**

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA): (a) and (b) Participation of the private sector in postal services has been marginal and that too in the role of augumen-

ting the efforts of the Department to provide basic postal facilities in the needy areas. Private agencies have been participating in identified area of activity like sale of stamps and stationery, transporta-j tion of mail and provision of additional public facilities at a few places, like Post Shoppe. In Andhra Pradesh also activities like sale of postage stamps and stationery through licensed stamp vendors is in vogue.

## **Popularisation of Internet for Educational** Purpose

1300. SHRI K. RAHMAN KHAN: Will the Minister of COMMUNICATIONS be pleased to state:

- (a) the measures taken by Government to make the internet more popular for educational purpose;

Further w.e.f. .1.1.98 the educational Institutions are charged Rs. 4 lacs per annum instead of the normally charged Rs. 8 lacs per annum"for the 64 KPBS port. The relevant Circulars are annexed herewith Statement-I (See below).
