THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI BABU LAL MARANDI): (a) to (c) The matter is being enquired into and the factual position would be placed on the Table of the House.

Action plan for forests, wild life and environment degradation

Minister of ENVIRONMENT AND
FORESTS be pleased to state:

- (a) whether Government have formulated a coordinated and well focused action plant to deal with major issues relating to forests, wildlife and environment degradation;
 - (b) if so, the details thereof;
- (c) whether action plan effectively involves the State Governments NGOs, Industry and International Agencies in implementation of the same; and
- (d) in what manner the experienced and knowledgeable prosessional activists, tribals and others associated with forests, are proposed to be involved in policy planning and implementation?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI BABU LAL MARANDI): (a) No, Sir.

Disposal and Management of Bio-Medical Waste

1414. SHRI SATISHCHANDRA SITARAM PRADHAN: Will the Minister of ENVIRONMENT AND FORESTS pleased to state:

- (a) whether it is a fact that the problem of scientific disposal and management of bio-medical waste has assumed critical proportions over the years;
- (b) if so, the details regarding the magnitude of the problem and the steps taken so far to deal with the problem and results thereof:
- (c) the details of fresh policy initiatives taken by Government in this regard;
- (d) the details of action plan finalized for the current year and the Ninth Five Year Plan to deal with the problem; and
- (e) the details of proposals received in this regard and the action taken thereon?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI BABU LAL MARANDI): (a) and (b) Although the scientific disposal and management of

bio-medical waste is a matter of concern and needs to be addressed adequately, the Government is not aware of any finding indicating that the problem of scientific disposal and management of bio-medical waste has assumed critical proportions.

- (c) The Government has issued the Bio-Medical Waste (Management and Handling) Rules, 1998 on July 27, 1998.
- (d) and (e) The Action Plan for implementing the Bio-Medical Waste (Management and Handling) Rules, 1998 is stipulated in the above Rules which is as follows:-

The Action Plan is to be implemented by the State Governments/Union Territory Governments.

Killing of Endangered Animals

1415. SHRI KRISHNA KUMAR BIRLA: Will the Minister ENVIRONMENT AND FORESTS be pleased to state:

- (a) whether Government are aware that a large number of endangered animals are being killed in the country every year:
- (b) if so, whether Government have formulated any plan to protect and save
- (c) is so, the details thereof and the details of such animals killed during the last two years:
- (d) whether Government propose to prescribe stricter punishment for those involved in killing the endangered animals: and
 - (e) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS **BABU** LAL (SHRI MARANDI): (a) Instances of killing of endangered animals have come to the notice of the Government from time to time.

- (b) and (c) Yes, Sir. The States have been asked to set up co-ordination committees of all enforcement agencies, so that there is effective co-operation to check poaching and illegal trade. Staff in National Parks and Sanctuaries are being provided modern arms wireless equipment and communication facilities. Numbers of wild animals including endangered animals reported to be killed during the last two years in different States is given in the statement (See below)
- (d) and (e) The Wildlife (Protection) Act. 1972 as amended in 1991 is a comprehensive legislation which empowers the State Governments/UTs to have effective control over the .. management of wildlife and protection of the endangered species. The punishments for various offences provided in the Act have been found to be by and large adequate.
