(c) Action is on to appropriately amend the Memorandum of Association and Rules and Regulations of the Lalit Kala Academy and hand over the management of the Academy back to the duly constituted governing bodies early next year. The intention is to have a proper balance between autonomy and accountability.

Brain Drain

- (a) whether it is a fact that a large number of talented students go to USA and other advanced countries for higher and specialised studies, take up lucrative jobs abroad after completing studies and ettle over there, causing serious brain drain with preferred destination;
- (b) if so, the details regarding outflow and inflow of young professionals, including doctors, engineers and computer engineers during the last ten years, indicating the recent trends and the number of those who settled there permanently; and

(c) whether Government have taken/proposed any measures for reversal of the trend to check the brain drain effectively, by providing best possible work environment and better remuneration to the young talented and highly experienced scientists on return; if so, the details thereof?

MINISTER OF THE HUMAN RESOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) to (c) Some Indian Scientists, Engineers and Doctors do go to other countries for jobs and higher studies. However, no specific record about the numbers is maintained in this regard. In the present situation of global inter-dependence, inter-action of institutions in one country institutions and academies in another country is inevitable. Several steps have been taken from time to time by the Government to minimise the outflow as also attract Scientists and Technologists settled abroad to return to India. Some of these are:

- creation of new Scientific Department/Organisations;
- setting up of more centres of excellence/advanced studies in Universities and academic institutions;
- --- creation of core groups of professionals with necessary modern facilities required for pursuing research in new and frontier areas of science;
- S&T based training from Entrepreneurship Development Board (Department of Science & Technology);
- manpower development training/ retraining programmes through associateships/fellowships/courses;
- provisions for temporary placement of Scientists and Technocrats under the scheme of Scientistis' pool;
- invitation to distinguished men and women of Indian origin settled abroad for short term technical

assignments to assist in frontier and emerging areas of S&T.
