## Affairs of Himalayan Mountaincering Institute

1514. SHRI DAWA LAMA: Will the Minister of HUMAN RESOURCE DE-VELOPMENT be pleased to state:

(a) whether Government are aware that large number of ex-defence personnel have been posted in Himalayan Mountaineering Institute, Darjeeling in lieu of local experts;

(b) whether as a result thereof, a number of residential complexes have been constructed within Himalayan Mountaineering Institute Complex;

(c) whether this has resulted to ecological imbalance; and

(d) if so, the action proposed to save Himalayan Mountaineering Institute?

THE MINISTER OF HUMAN RE-SOURCE DEVELOPMENT (DR. MURLI MANOHAR JOSHI): (a) As informed by Himalayan Mountaineering Institute, Darjeeling, no ex-defence personnel have been posted in lieu of local experts. However, six ex-defence personnel have been employed in the Institute as Peon (1), Chowkidars (2), Upper Divison Clerk (1), Catering Assistant (1), and Driver (1).

(b) No new residential building has been constructed in HMI since April, 1989. However, a Group 'D' Quarter Block was constructed by the Institute during 1993-94, which is located outside the HMI complex. The block has ten quarters and only one Ex-Defence personnel is staying in that block.

(c) No such ecological imbalance has been reported by the Himalayan Mountaineering Institute.

(d) Does not arise.
