(c) and (d) Industrial Development Bank of India (IDBI) has recommended financial restructuring of Steel Authority of India Ltd. (SAIL) which primarily envisages relief from Steel Development Fund (SDF) loan/Government of India loan towards writing down of fixed assets to the extent of interest capitalised, writing-off of loans and advances given by SAIL to IISCO, etc. The IDBI have, in their report, inter-alia also concluded that SAIL should consider business solutions as a long term strategy for improving operations and enhancing returns such as rationalization/divestment of idle or non-core assets, divestment from unrelated/non-core operations, and of loss making units, etc.
