Wetleasing of aircraft from Aeroflot

1709. SHRI RAHASBIHARI BARIK: Will the Minister of CIVIL AVIATION be pleased to state:

(a) whether the Aircraft operating on Delhi/Moscow/Delhi sector has been taken on wet lease from Aeroflot;

(b) if so, the details of the lease deed thereof:

[15 DEC. 1998]

- (c) whether the flight purser and two Air Hostesses for the above sector have to come to Delhi for their assignment;
- (d) if so, the expenditure incurred by the A.I. on them;
- (e) the reasons for not utilising the services of the originating/terminating stations crew members; and
- (f) the steps taken by the Government in this regard?

THE MINISTER OF CIVIL AVIATION (SHRI ANANTH KUMAR): (a) and (b) Air India has taken IL-62 M aircraft capacity on wetlease from Aeroflot for its once weekly operations on the sector Delhi/Moscow/Delhi. The lease charges are USD 5,000/- per flying hour. The lease agreement is valid upto October 31, 1999.

(c) to (f) As per lease agreement, the leased aircraft is served by five or six cockpit crew and five cabin crew of the lessor. In addition, Air India provides one flight purser and two airhostesses who are based in Delhi. Hence no additional expenditure is incurred on their transportation.
