Policy for LpG dealership in Tehsil Headquarters of Hilly areas

1968. SHRIMATI CHANDRESH KUMARI: Will the Minister, of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) the present policy to allot LPG dealership in Tehsil Headquarters of a Hilly State:
- (b) whether the present policy of LPG dealership in Hilly areas has been reducing the forest areas of the region;
- (c) whether the consumers of LPG in Hilly areas have to carry heavy LPG cylinders at risk of their lives;
- (d) whehter Government propose to amend the existing LPG dealer ship rules ^ set up the same in vil-

lages to avoid the apprehension as in parts (b) and (c); and

(e) if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) LPG distributorships are opened in the country subject to the locations meeting the feasi • bility and economic viability norms of the Oil Industry including in the hrily areas.

- (b) hi order to protect the forests in hilly areas, Government has allowed release of LPG connections across the counter at the locations situated above the altitude of 2000 ft. MSL in all the hilly areas.
- (c) to (e) Generality, home delivery of LPG refills is made in maip markets, where the LPG distributorship is located. In hilly areas, the villages are generally thinly populated and are situated far off from the main distributor's point and scattered in different directions. Under such circurnstances, it becomes too prohi-

bitive for LPG distributors for providing borne delivery from the cost, angle.

However, in hilly areas because of high cost of delivery, which cannot oe fully compensated threugii the distributor con (mission, the concerned district authorities authorise LPG distributors collection/ recovery of additional specific liftme delivery charges called as cooliage charges from the domestic LPG consumers. Therefore, there is no proposal to amend the existing rule in respect of hilly areas.

LpG Waiting List

to Unstarred Questions

- 1970. SHRI S. M. KRISHNA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to refer to reply to Unstarred Question 409 given in the Rajya Sabha on the 2nd December, 1998 and state:
- (a) what is the criteria for preparing waiting list for LPG and whether there is any mechanism with Government's to periodically review/regulate the list;
- (b) whether Government's attention has been drawn to the newsitem captioned "LPG connections, the wait goes on" which appeared in the Hindustan Times, dated the 25th August, 1998, if so, the reaction of Government thereto, and
- (c) the action taken so far against the guilty people for alleged malpractices in oil companies?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) It is mandatory for all the PSU Oil Cooio* ies distributors to maintain a waitlist register for regisration of prospective customer wishing to avail of an LPG connection. As per the exist-ing practice, no registration fee for booking of a gas connection is being charged. New LPG connections are released strictly on the basis of seniority in the waitlist maintained by distributors within the allocation given by the Oil Companies. Regular/surprise inspections of the LPG distributor- ships are also carried out by the oil company officials which includes verification in regard to release of LPG connections against waitlist in order of seniority of regist^ ration.
