Situation in the Defence production Unit at Saintala in Orissa

1900 SHRI BHAGABAN MAJHI: Will the Minister DEFENCE be pleased to state:

- (a) whether Government aware of the tense situation prevailing at the Defence Production Unit at Saintala near Titlagarh in Bolangir district of Orissa;
- (b) whether it is due to inadeattention paid by the Defence Production unit in the recruitment of candidates for various posts, and
- (c) if so, the steps taken by Government to resolve the prob-

THE MINISTER OF DEFENCE (SHRI GEORGE FERNANDES): (a) There is no tension prevailing at the Defence Production which is running smoothly. However, there is some tension outside the defence area arising out of the unrest amongst unemployed youth desirous of getting employment in the factory.

Entry of microlight pilotless air craft in Indian territory

- (a) whether the security in J&K have recently seized microlight pilotless aircrafts bearing Pakistani and Taiwanese marks in the border districts of Rajouri;

- (c) how the pilotless aircrafts entered in our territory and whether the security agencies at border are negligent in their duties;

- (d) whether any serious investgation has been made into the incident; and
 - (e) if so, the details thereof?

THE MINISTER OF DEFENCE (SHRI GEORGE FERNANDES): (a) to (e) There is no report of recovery of any micro-light pilotless aircraft in J&K. Two models are however reported have been recovered by J&K police in Rajouri district on 5th Nov. 98. Details of the aero-models recovered are as under:—

- (a) Made of Balsa wood from Taiwan, with a Japanese engine.
- (2) Length of the model is feet with a wing span of feet.
- (c) Radio control set with four channels.
- (d) Total weight is 4.5 kg with a payload of 500g to one kg.
- (e) Capable of achieving speeds of 80-100 Kmph and ky upto 4000' to 5000' above ground level.
- (f) Can be manoeuvred by a handler within a radius of 1 to 1.5 km based on line of sight and fly up to 20 to minutes at a stretch.

The investigation is being carried out by the local police. Security Forces are maintaining constant vigil on the borders.

Considering the ever changing operational/strategic requirements, any of these airfields may be required to be used in future. Therefore, in the interest of national security, it would not be desirable to disclose the details in this regard.

The Indian Navy was represented India was unaniat the Forum mously granted observer status and India's inclusion in the forum has been welcomed by all the participants. It was accepted that continued multilateral links and cooperation at the professional would enhance security, cooperation and mutual understanding.
