  - -Special Cultural events
  - (d) and (e) No, Sir.

# **Drop in Foreign Tourist**

- 2011. SHRI KUSHOK THIKSEY: Will the Minister of TOURISM be pleased to state:
  - (a) whether it is a fact that there is 40 rer cent drop in the number of foreign tourists visiting the country;

THE MINISTER OF STATE IN THE MINISTRY! f OF TOURISM (SHRI OMAK APANG):

- (a) and (b) There has been a marginal decline of 0.6 per cent in tourist arrivals during the period from January-November 1998 a\$ compared to the corresponding period of the previous year. The decline has been primarily due to economic crisis m South East Asian countries, general elections in India, high room tariffs in metro cities, etc.
- (c) Tourism indusry is eligible for various incentives and the units with foreign 'exchange earning of Rs. 6 crores and above has been now accorded export house status.

# Development of Tourism in Himachal Pradesh

- 2012. SHRIMATI CHANDRESH KUMARI: Will the Minister of TOURISM be pleased to state:
- (a) whether Government have accorded the status of Industry to Tourism;
- (b) if so, the details thereof with details of relevant instructions:

#### THE MINISTER OF STATE IN T!HE MINISTRY] OF TOURISM (SHRI OMAK APANG):

- (a) and (b) The Government of India has accorded Export House Status to Tourism. Hotels, Travel Agents, Tour Operators, Tourist Transport Operators shall be entitled for recognition as Export House/Trading House/Star Trading House/Super Star Trading House vide Government of India, Ministry of Commerce Notification No. 33 dated 26-11-98. Consequently, they shall be entitled to such benefits as specified in Chapter 12 of the Hand Book of Procedures (Vol. I).
- (c) The development of tourism is primaily the responsibility of the State Governments. However, Union Ministry of Tourism provides financial assistance for tourism infrastructure for which State Governments seek assistance.
- (d) and (e) The granting of industry status and consequential benefits thereof would help in the development of tourism which would ultimately result in higher foreign exchange earnings.

# **Development of Tourism in Kerala**

- 2013. VAYALAR RAVI: Will the Minister of TOURISM be pleased to state:

THE MINISTER OF STATE IN THE JVIINISTRY OF TOURISM (SHRI OMAK APANG): (a) and (b) Ministry of Tourism in consultation with the State Government has prioritised 15 projects amounting to Rs. 467 lakhs for the development of tourism in the State of Kerala.

(c) There are 4 tourist centres in Kerala which are Bekal, Cochin, Kovalam and Trivandrum. There is no proposal to introduce more tourist centres in Kerala. No proposal from the State Government has been received for introducing house boats in the veinland lake. However, the project to purchase house boats for Malabar has been prioritised for the current financial year for Rs. 50.00 lakhs.
