

Bullet proof jackets and sophisticated weapons to Delhi Police

1988. SHRI KRISHNA KUMAR BIRLA: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether the Delhi Police personnel are not equipped with bullet proof jackets resulting in problems while facing the hardcore criminals/terrorists;

(b) if so, whether in the past few months attacks on Delhi Police personnel were made by terrorists/criminals;

(c) if so, the facts and details thereof; and

(d) the steps Government propose to take to provide bullet proof jackets and highly sophisticated arms to the Delhi Police personnel to face criminals and terrorists?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI CHENNAMANENI VIDYASAGAR RAO): (a) to (c) Bullet proof jackets are available with Delhi Police and are provided to the staff on specific demand. The details of the cases in which police personnel were attacked since January, 2001 are given in the attached statement. (*See below*)

(d) The procurement of material to replenish the stock or meet additional requirement is a continuing process.
