THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA): (a) Yes, Sir. The representation regarding request to connect Jangla telephone exchange to Rohru instead of Chirgaon to which it is presently connected have been received.

(b) and (c) The telephone exchange installed at Jangla is working satisfactorily. There was some electrical induction on the physical cable which has been set right to provide satisfactory performance for STD calls.

In order to provide better reliable connectivity with adequate circuits, it has been planned to connect Jangla exchange with Rohru telephone exchange (instead of Chirgaon to which it is presently connected) on Aerial Optical Fibre Cables during 1999-2000.
