Supervision of rural telecom package

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI RABINDRA PURKAYASTHA): (a) to (c)The Rural Telecom Package announced in November, 1995 envisaged concessional tariffs, enhanced free calls, lower registration fee and rental etc. to rural subscribers. The various features as envisaged in the package have been extended to all eligible place in the country.

However, there were no specific targets with regard to the package and no separate monitoring authority was appointed.
