Linking of Gurgaon with Ghaziabad and Noida

2087. SHRI OSCAR FERNANDES: Will the Minister of COMMUNICATIONS be pleased to state:

- (a) whether it is a fact that Faridabad has been linked with Noida and Ghaziabad, whereas Gurgaon has been left out;
 - (b) if so, the reasons therefor; and
- (c) by when Government propose to link Gurgaon with Ghaziabad, Noida and Bahadurgarh?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA): (a) and (b) Faridabad has local call facility at 180 sec pulse rate (i.e. Inter dialling without STD Code) with Noida and Ghaziabad, however Gurgaon is only linked with STD facility.

As per policy local call facility is provided within a Short Distance Charging Area (SDCA) which generally corresponds to a Teshil. However, local call facility at 180 sec pulse rate (i.e. Inter dialling without STD code) is provided.

- (i) Between adjacent SDCAS
- (ii) When the radial distance between Short Distance Charging Centres (SDCCs) of two SDCAs is upto 20 Kms.

This facility therefore has been provided between Faridabad SDCA and Ghaziabad (including Noida) SDCA which are adjacent. The provision of facility between Gurgaon SDCA and Ghaziabad (including Noida) SDCA is not provided as both the SDCAs are

nonadjacent and the Radial distance between their SDCCs is more than 20 Kms.

(c) The provision of local call facility at 180 sec. pulse rate (i.e. inter-dialling without STD code) between Gurgaon with Ghaziabad (including Noida) and Bhadurgarh is not permissible as per policy explained at (a) & (b) above.
