been disposed of by Vigilance during the last three years?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI MUKHTAR NAQVI): (a) and (b) No, Sir. However, the Music Audition Rules, 1988 has empowered Director General, All India Radio to dispense with the need for an actual audition for the purpose of assessment and gradation of an artist on the recommendation of the programme Head of the Station or Director of Programmes (Music) or any Member of the Music Audition Board or local Audition Committee. The exemption is given only for those artists who are popular and have eminence in the music field. On the basis of the extant Rules, the Directorate General of All India Radio have awarded Grades to some artists of different discipline by assessing the recordings of their latest performances. As the criteria for award of grades to the artist is based on the performance quality, popularity and achievements of the artist in the music field. there is no question of allowing back door entry of artist.

- (c) No such case is pending for Vigilance enquiry.

# Clarnet/flute instruments in music section of AIR

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI MUKHTAR NAQVI): (a) to (c) 12 flutes purchased in July, 1993 and one clarnet purchased in December, 1962 at Delhi Station of All India Radio have become obsolete. Action has already been initiated to procure their replacement. However, each instrumentalist normally prefers to play his personal instrument when accompanying the artists. AIR keeps these instruments as stand-by.

### Statement-II

#### Print Media

In so far as print media is concerned, the Government continues to be guided by the Cabinet Decision of 1955 which inter-alia prohibits publication of foreign owned newspapers/periodicals and of Indian editions of foreign newspapers/periodicals dealing mainly with news and current affairs. This policy has not been changed or rescinded so far.

# Electronic Media

In so far as Electronic Media is concerned. the following policy parameters are taken into account:--

- (a) All future laws on broadcasting will be applicable to them and they will not claim any privilege or protection by virtue of approval granted.
- (b) They will not undertake any broadcasting from the Indian soil.
- (c) Companies desiring to enter also in the marketing of software produced by them will observe the programme and Advertisement Codes of Doordarshan.
- (d) Flouting of these conditions may call for suspension of activity or cancellation of approval.

#### Film Sector

In so far as Film sector is concerned, Annexure-III of the Manual of Policy and Procedure governing Industrial Approvals (Item 35-covering Film sector) stipulates that automatic approval for 51% foreign equity participation in the Film sector is allowd by RBI. Beyond this, the investment is approved by the FIPB.

The policy regarding the quantum of foreign investment which should be allowed in the Film Sector is presently being considered by the Government.

#### Advertising

Government is presently considering to lay down norms prescribing extent of foreign equity permissible in Advertising sector.
