- (c) how many new post offices are proposed to be opened in Orissa during the current financial year?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA): (a) and (b)

No sir, only one application for opening of new Post Office at Madhupur Village is under examination and is pending finalisation due to non-receipt of complete information.

(c) A target for opening of Ten (10) Departmental Branch Post Offices and two (2) Departmental Sub Post Offices has been fixed for Orissa Circle during the current Plan 1998-99; subject to availability of resources.

## Telephone connections in Dakshinpuri Extension

(a) the number of O.Bs issued by the Mahanagar Telephone Nigam Ltd. under the Nehru Place Telephone Exchange during the year 1998 so far;

- (b) how many O.Bs were issued in Dakshinpuri Extension (DDA Flats) area during the year 1998;
- (c) whether it is a fact that O.B. issued in July has not given telephone connection so far in the said area; and
- (d) by when, telephone connections are likely to be given in Dakshinpuri Extension (DDA Flats) area?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA): (a) Sir, MTNL, Delhi issued 5249 OB's under Nehru Place Telephone Exchange during the year, 1998.

- (b) 439 OB's have been issued in Dakshinpuri Extension (DDA Flats) area during the year 1998.
- (c) Yes Sir, telephone connections could not be provided due to the area being technically not feasible.
- (d) Telephone connections in Dakshinpuri Extension (DDA Flats) are being provided progressively and are likely to be provided by March, 1999.

#### Expansion of internet connectivity

2071. DR. Y. LAKSHMI PRASAD: Will the Minister of COMMUNICATIONS be pleased to state:

- (a) whether Videsh Sanchar Nigam Limited propose to expand Internet connectivity services to different cities; and
- (b) if so, the details thereof and the number of Earth stations to be built in Hyderabad in this connection and when?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA): (a) and (b) Case is under examination of the Telecom Commission. No decision has been taken so far.

- (ख) जी हां।
- (ग) जी नहीं। अजय नगर डाक कालोनी की सप्पई के लिए स्थानीय पालिका प्राधिकारियों से अनुरोध किया गया था परन्तु उन्होंने इस संबंध में कोई कार्रवाई नहीं की। अत: विभाग उक्त कालोनियों में नागरिक सुविधाएं मुहैया करा रहा है।

# Refund of security deposits of telephones in Gurgaon

- (a) what are the number of cases where the telephones have been shifted/transferred in Gurgaon to third party and their security deposits are yet to be released even after a lapse of more than a year; and
- (b) by when Government propose to release their security deposit without waiting for their formal applications for refund of security deposit?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI KABINDRA PURKAYASTHA): (a) Sir, No case in pending under third party transfer in Gurgaon, where telephone has been shifted/transferred and security deposit yet to be released. However, one case for refund of security is pending. The concerned subscriber has been requested to furnish deposit documents.

(b) Does not arise in view of (a) above.
