1998, decided to recommend to the National Development Council a reduction in the target rate of growth of GDP from 7.0 per cent per annum to 6.5 per cent per annum average over the five years of the Ninth Plan. This has been done to take into account the actual realisation of 5.1% growth during 1997-98 (i.e., the first year of the Ninth Plan) and expected realisation of about 6% growth during 1998-99 (i.e., the second year of the Plan). Implicit in this target is more than 7% of average growth during the remaining three years of the Plan.

Action taken on the Report of Shukla Commission

2152. SHRI PRAKANTA WARISA: Will the PRIME MINISTER be pleased to state:

(a) what steps are being taken by Government to implement the various recommendations of schemes made by Shukla

Commission for the State of Assam;

- (b) if so, the details thereof along with the budgetary provisions made by Government during he current financial year and Ninth Plan, district-wise; and
- reasons for implementation of the said recommendations accepted by the Union Government?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS, MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME **IMPLEMENTATION** (SHRI RAM NAIK): (a) to (c) The Shukla Commission submitted its Report in March, 1997. Further action in the matter, including steps to constitute a Non-lapsable Central Pool of Resources for the North East, has since been initiated.

The Non-lapsable Central Pool of Resources is designed to assist development projects, such as in the infrastructure sector, in the North Eastern Region and Sikkim. The Central Poo! comprises of contributions from the concerned Union Ministries/Departments from out of unspent amount (s) from 10% of their Budget (s) earmarked for the North East and Sikkim.

Project proposals relating, inter-alia, to the

recommendations of the Shukla Commission, are envisaged to be identified from time to time for assistance, on merits, from the Central Pool.

Planning Commission's remark on **Import Policy**

2153. SHRI O.P. KOHLI: Will the PRIME MINISTER be pleased to state:

(a) whether the Planning Commission in a recent analysis of current status of imports and exports of agricultural and allied commodities has warned that the present import policy of some food items like wheat,

pulses, edible oils and sugar could act as a disincentive to the Indian fanners adversely affecting the growth of the country's agriculture; and

(b) if so, the steps taken to make the country self-sufficient in these items?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS, MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME **IMPLEMENTATION** (SHRI RAM NAIK): (a) and (b) Planning Cemmission has neither carried out any analysis recently of the current status of imports and exports of agricultural and allied commodities nor has issued any warning to imply that the present import policy of some food items like wheat, pulses, edible oils and sugar could act as a disincentive to the Indian farmers adversely effecting the growth of the country's agriculture.

- (c) whether there is any proposal under Government's consideration to declare some more areas as backward; if so, what are the

details thereof and by which time it is likely to be implemented?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS, MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY **AFFAIRS** AND MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION (SHRI RAM NAIK): (a) to (c) Planning and Development of an area and allocation of funds for the purpose is primarily the responsibility of the concerned State Government. Planning Commission have not identified any area as backward per se. However, Central Government supplements the efforts of the State Governments, including Himachal Pradesh, in the development of backward districts through appropriate weightage for backwardness in the formula used for distribution of Normal Central Assistance. Further, Special Central Assistance is allocated under Special Area Programmes and various poverty alleviation schemes.

- (a) the details of main objective and structure of Border Area Development Programme;
- (b) the details of specific State-wise location including Gujarat where border programmes are to be implemented during the Ninth Five Year Plan;
- (c) the details of the projects implemented during Eighth Five Year Plan period in the North-Western areas; and
- (d) the details of allocation made to implement the projects in the said area during the current financial year?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS, MINISTER OF STATE IN THE MINISTRY OF PARLIA-MENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF PLANNING AND PROGRAMME IMPLEMENTATION (SHRI RAM NAIK): (a) The main objective

- of the Border Area Development Programme (BADP) is to meet the special needs of the people living in remote, inaccessible areas situated near the border. Schemes which address problems such as inadequacies related to provision of essential needs, strengthening of the social infrastructure, filling up of critical gaps in the road network etc. may be taken up under the programme. BADP is a 100% centrally funded area programme.
- (b) The programme is in operation in the border blocks of states which border Pakistan, Bangladesh and Myanmar, namely, Arunachal Pradesh, Assam, Guiarat, Jammu & Kashmir, Manipur, Meghalaya, Mizoram, Nagaland, Punjab, Rajasthan, Tripura and West Bengal.
- (c) The decisions regarding the schemes/ projects to be undertaken in each State are taken by the State level Screening Committees. After the programme was revamped in 1993-94 the North-Western States of Gujarat and Rajasthan were allocated Rs. 32.07 crore and Rs. 322.76 crore respectively, during the Eighth Plan, and the schemes undertaken relate to education, health, water supply, roads, security etc.
- (d) In the current year the Governments of Gujarat and Rajasthan have been allocated Rs. 8.88 crore and Rs. 56.52 crore respectively under BADP.
