Uplinking facility at Imphal Station

2108. SHRI W. ANGOU SINGH: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) whether AIR has not got uplinking facility which may link State and National channel at Imphal station;

(b) whether this uplinking facility could be provided before the National Games to be held at Imphal; and

(c) whether Government are aware that the present transmitter cannot take AIR programmes to the hill areas of the State and by when the single channel AIR station will be converted into the second channel?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI MUKHTAR NAQVI): (a) Yes, Sir.

(b) No, Sir. Uplinking facility at Imphal would only be ready by the end of the current financial year.

(c) Day time radio coverage by area and population is 99%. Therefore, coverage can be taken as 100 without taking into consideration the special requirement of certain situations. In 9th plan, there is a proposal for setting up a 10 KW FM Transmitter with stereo facilities at Imphal.

फिल्मों को उद्योग का दर्जा

2110. श्री चीमनभाई हरीभाई शुक्ला : क्या सूचना और प्रसारण मंत्री यह बताने के कृपा करेंगे कि :

(क) क्या सरकार ने भारतीय फिल्मों को पूर्ण उद्योग का दर्जा प्रदान किया है,

(ख) यदि हां, तो क्या सरकार ने भारतीय फिल्मों के कार्य को आद्योगिक उत्पादन के बराबर माना है,

(ग) देश में फिल्मों के निर्माण के लिए उपलब्ध कराई गई सुविधाओं का ब्यौरा क्या है, और

(घ) क्या इस उद्योग से जुड़े सभी कार्मिकों के हितों की रक्षा और भविष्य के लिए कोई योजना बनाई गई है ?

सूचना और प्रसारण मंत्रालय में राज्य मंत्री (श्री मुख्तार नकवी) : (क) से (घ) सरकार ने फिल्म क्षेत्र को 'उद्योग' का दर्जा प्रदान कर दिया है । इस निर्णय के परिणामस्वरूप भारतीय औद्योगिक विकास बैंक अधिनियम, 1964 के अन्तर्गत संस्थागत वित्त के लिए उपयुक्त कार्य-कलाप की सूची में फिल्म निर्माण तथा अनुषंगी कार्यों को शामिल करने के लिए वित्त मंत्रालय से अनुरोध किया गया है ।

सरकार ने फिल्म उद्योग विकास परिषद् का भी गठन किया है जो अन्य बातों के साथ-साथ उद्योग के कार्यबल की कार्य शर्तों में सुधार लाने के उपायों को अपनाने की सिफारिश करेगा ।

इस मंत्रालय को एवं फिल्म तथा श्रव्य-दृश्य निर्माण संबंधी निर्यात संवर्धन न मंच और फिल्म उद्योग के विस्तार एवं विकास संबंधी विभिन्न विषयों पर सलाह देने के लिए सहकार दल का भी गठन किया गया है ।

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI MUKHTAR NAQVI): (a) and (b) The film on Gandhiji under the title "Mahatma" belongs to Gandhi Smarak Nidhi, Manibhavan, Mumbai. The archival negative of the film is preserved with them. Films Division was supplied with only one copy of one print by the Gandhi Smarak Nidhi 24 years back which started decomposing with the passage of time.
