THE MINISTER OF COMMERCE (SHRI RAMAKRISHNA HEGDE): (a) to (c) As per the Import Policy, cigarettes (IT CHS Code 24.02) fall under Restricted List of items. No proposal has been received for allowing import of cigarettes for the purpose of reexport. Under the Duty Exemption Scheme, there are no norms where import of cigarettes is allowed for re-export of cigarettes.

## **DEPB** rates

- 2337. SHRI S. AGNIRAJ: Will the Minister of COMMERCE be pleased to state:
- (a) what is the total number of applications pending for fixation of DEPB rates as on
- (b) whether it is a fact that exporters are not getting any benefit due to the delay in fixing DEPB rates;
- (c) whether it is also a fact that due to stringent guidelines many small exporters are not able to get the rates fixed for these items;
- (d) if so, what steps are being taken to improve the system?

THE MINISTER OF COMMERCE (SHRI RAMAKRISHNA HEGDE): (a) Fixation of DEPB rates is a continuous process. As on date, 68 applications are pending for fixation of rates.

- (b) All exporters are not. covered by the DEPB scheme. For cases which are not covered by this scheme, two other alternative schemes are available, namely, the Duty Drawback Scheme and the Advance Licensing Scheme, under which duty relief is provided to the exporters.
- (c) and (d) The guidelines are not stringent. A standard . procedure to be followed for deciding the DEPB rates is laid down under para 7.25 of the Exim Policy, 1997—2000 and Appendix 52 of

the Handbook of Procedure Vol. 1, 1997-2000 as amended.

THE MINISTER OF COMMERCE (SHRI RAMAKRISHNA HEGDE): (a) As per the provisional data received from the Directorate General of Commercial Intelligence & Statistics (DGCI&S), the trade deficit during 1997-98 was to the tune of US \$ 6799 million. During April-October, 1998-99 the- trade deficit has been estimated as US S 5797 million.
