# Pak's plan for Massive Infiltration in Jammu and Kashmir

- 2715. SHRI O.P. KOHLI: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether Government's attention has been drawn to the news-item published in the Statesman, dated the 13th November, 1998 captioned "Massive infiltration planned in Jammu and Kashmir.";
- (b) whether by organising a large scale infiltration of armed mercenaries into Jammu and Kashmir, Pakistan is planning to create a situation similar to that of 1965 in the State when it had sent thousands of armed infiltrators into the State to spread violence leading to a war in the sub-continent; and
- (c) if so, Government's reaction thereto and emergency measures being taken to counter this potential threat?

THE MINISTER OF HOME AFFAIRS (SHRI L.K. ADVANI): (a) Yes, Sir

- (b) While it is true that Pakistan have been continuedly trying to infiltrate terrorists including foreign mercenaries into Jammu & Kashmir to keep up the level of militancy, there is, however, no authentic information about their having any plan of starting a war in the subcontinent.
- (c) The Government have adopted a multi-pronged approach to tackle infiltration on the border which includes interalia, strengthening the border management, gearing up intelligence machinery, improved interaction with border population, setting up of outposts of security forces, constituting Village Defence Committees, modernisation and upgradation of police and security forces with advanced/sophisticated weapons and communication systems etc.

### Smuggling of Counterfeit Notes

- 2717. SHRI SATISHCHANDRA SITARAM PRADHAN: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that lakhs of counterfeit notes are smuggled from across the border;
- (b) if so, the total amount of fake currencies ceased, so far;
- (c) the estimated amount of fake currency under circulation; and
- (d) whether Government propose to issue the details of such fake currency identification for the use of common people?

THE MINISTER OF HOME AFFAIRS (SHRI L.K. ADVANI): (a) to (c) Circulation as well as seizure of fake currency notes have been reported from time to time in some parts of the country. According to available information, the total value of forged Indian currency notes recovered/seized during the year 1998 (upto September) was R.

- 23,68,725. The value of forged currency notes in circulation cannot be ascertained with any degree of certainty.
- (d) The Reserve Bank of India issues press releases, from time to time, to enable the public to distinguish between genuine and fake currency notes.

- (a) whether it is a fact that a large number of I.S.I. activists and sympathisers have joined political parties to camouflage their relations with I.S.I.:

- (c) if so, the political parties with which these people are associated?

THE MINISTER OF HOME AF-FAIRS (SHRI L.K. ADVANI): (a) to (c) No information is available with the Government in this regard.

THE MINISTER OF HOME AFFAIRS (SHRI L.K. ADVANI): (a) to (c) Information is being collected and will be laid on the Table of the House.

#### Attack on Minoritles

2720. SHRI NILOTPAL BASU: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government are aware of severe attacks on the minorities especially Christian minorities in different parts of the country; and
- (b) if so, the details thereof and steps contemplated for arresting eliminating such unseemly developments Minorities through the National Commission?

MINISTER OF HOME THE AFFAIRS (SHRI L.K. ADVANI): (a) No Sir. However, some isolated incidents of attacks on minorities including Christians in certain parts of the country have been reported.

National Minorities (b) The Commission to be is understood enquiring into these incidents; the State have been Governments concerned advised to take action against the alleged wrong-doers.
