Tourism Counter at IGIA

2777. SHRI SITARAM KESRI: Will the Minister of TOURISM be pleased to state:

- (a) whether Government's attention has been drawn to the News-item appearing in "Hindu" dated 9th November, 1998 under the caption "Tourism Counter at IGIA run by touts";
- (b) whether Government have made any enquiry in the matrer; and
- (c) if so, how far the facts stated in the news-item are true and the action taken in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRI OMAK APANG) (a) Yes, Sir,

(b) and (c) Airports Authority of India (AAI) has issued license to M/s Punjab Tourism Development Corporation, a state Government undertaking for the "Tourism Counter" at IGI Airport. A complaint hs been received by AAI that PTDC has leased it out to a Patiala based private transport Co. and the matter is being investigated. AAI proposes to take action against PTDC in case there is any violation of the terms & conditions of the license agreement.

Route of Amarnath Through Baltal

2778 SHRI VEDPRAKASH P. GOYAL: Will the Minister of TOURISM be pleased to state:

- (a) whether it is a fact that alternate route to Amarnath through Baltal reduces the travel time from three days to just four-five hours and around one fourth pilgrims used it this
- (b) the steps taken so far or proposed to be taken by Government to develop this dangerously narrow mountainous track, which has been opened this year after a gap of nine years;
- (c) the steps taken so far to involve the participation of voluntary organisations and NRIs to improve the tourism facilities, that could benefit the village families enroute through employment and trade; and
 - (d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRI OMAK APANG) (a) Yes, Sir. The travel time between Baltal and Amarnath (to and fro) gets reduced to one day approximately even though some people take a little longer. During the 1998 Amarnath Yatra, as many as 39084 yatris out of a total of 1,49,920 Yatris used this route.

(b) The track from Baltal is maintained by the State Government and normal upkeep of the track is undertaken by them on a regular basis every year.

Written Answers

Development (c) and (d) and pilgrim management of centres is primarily the responsibility of the State Governments. The Ministry of Tourism, Government of India provides central financial assistance to State Governments and funds are released keeping in view the inter-se-priority of projects, subject to availability of funds, on the basis of the projects submitted by them.

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRI OMAK APANG) (a) and (b) Yes Sir. The Ministry of Tourism have received the following project proposals from Punjab Government in connection with celebrations of Tricentenary of birth of Khalsa at Anandpur Sahib:—

- SEL Show_ at Gurudwara Anandpur Sahib.
- 2. Illumination at Gurudwara Teg Bahadur, Anandpur Sahib.
- 3. Illumination at Gurudwara Mai Jito Ji, Anandpur Sahib.
- 4. Illumination at Gurudwara Kila Anandgarh Sahib.
- 5. Illumination at Gurudwara Kesh Garh Sahib, Anandpur Sahib.

6. Tourist Reception Centre at Anandpur Sahib.

Sanctions of these projects have been issued and first instalment has also been released to the State Government.

Importance of Domestic Tourism

- (a) whether it is a fact that the domestic tourism has not been given the importance and attention it deserves;
- (b) if so, the steps taken to develop the infrastructure for the promotion of domestic tourism; and
- (c) the details of the scheme prepared for the purpose for Ninth Plan State-wise?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM (SHRI OMAK APANG) (a) No, Sir.

(b) and (c) Promotion of domestic tourism is primarily the responsibility of the State Governments. The Ministry of Tourism, Government of India has been providing financial assistance to the State Governments for the creation of facilities for domestic tourism such as construction of tourist complexes, way-side amenities cafeterias; purchase of adventure sports equipments; flood-lighting and refurbishment and landscaping of monuments and heritage properties, setting up Sound & Light shows, construction of yatriniwas, yatrikas; promotion of handicrafts and folk culture, craft melas, important festivals and fairs. Publicity brochures on various tourist destinations have been brought out for the information of tourists. These schemes are included in the Ninth Plan budget of the Ministry.
