THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) and (b) 46 retail outlet dealerships and 34 LPG distributorships have been allotted in Assam during last 5 years i.e. from 1993-94 to 1997-98.

(c) and (d) As per existing policy, reservation for different categories is provided as under:

33% of the dealerships/distributorships in all the categories mentioned above are reserved for Women belonging to that category. Other things being equal, Unmarried women above 40 years of age without earning parents and Widows are given priority over others. There is no separate reservation for terrorists affected widows.

## Premetion of SC candidates in Mathura refinery

2760. SHRI R.N. ARYA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether it is a fact that National Commission had issued direction for ED Mathura Refinery and Chairman IOC to promote SC candidate for the post of Instrumentation Engineer MRP Mathura; and
- (b) why did a general candidate get promoted in place of a SC candidate available on eligibility?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) and (b) The National Commission for Scheduled Castes and Scheduled Tribes had advised the Indian Oil Corporation Ltd. (IOC) In April 1998 to hold a review DPC to give effect to the promotion of an SC candidate to the post of Instrumentation Engineer. The Corporation informed the Commission in May' 1998 that it was not feasible to implement the advice within the framework of Presidential Directives and the latest guidelines on SC/ST matters. Since there was no shortfall of candidates cadre in the Instrumentation Engineer, the case of the SC candidate was considered by the DPC alongwith other eligible candidates in the feeder cadre for promotion against in unreserved vacancy. However, he could not make the grade and a general candidate who was also the senior most. was promoted on merit against this unreserved National vacancy. The Commission also informed was accordingly by IOCL.
