(d) and (e) In order to cater to the increased demand of LPG, in addition to the locations pending from the previous marketing plans, 38 new LPG distributorships have been included in the approved LPG marketing Plan 1996—98.

#### CNG Filling Facilities

2748. SHRI YERRA
NARAYANASWAMY: Will the Minister of
PETROLEUM AND NATURAL GAS be
pleased to state:

- (a) whether oil companies have been directed to provide a network of CNG filling facilities widely all over the country;
- (b) how many outlets are there of Indian Oil Corporation supplying CNG for motor vehicles:
- (c) whether any efforts has been made to popularise CNG;
- (d) the number of CNG outlets will be opened in Andhra Pradesh in 1998-99; and
- (e) the details of plans of Government to utilise the public sector oil companies to popularise CNG?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) No, Sir. It is possible to supply CNG only where natural gas pipeline supply is avialbale. At present, CNG is being supplied only in Mumbai, Vadodara, Surat and Delhi. The Gas Authority of India Limited has been directed provide a network of CNG filling facilities in Delhi. For this purpose, oil marketing companies have also been asked to identify some retails outlets.

- (b) So far, there are five outlets of Indian Oil coporation supplying CNG for motor vehicles in Delhi, Mumbai and Vadodara.
- (c) Yes, Sir. Publicity campaigns to popularise the use of CNG in cities where it is being marketed have been launched. In addition, lower rates of import duty of

5% are being levied on CNG conversion Kits which have to be imported.

- (d) None.
- (e) A few of the CNG on-line dispensing units are to be established at the existing retail outlets of the oil companeis.

# Gas and Petrotanker Explosion in Guwahati

2749. Dr. ARUN KUMAR SARMA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) the ciricumstances that let to the recent gas and petrotanker explosion in Guwahati, details of casualty and total loss incurred;
- (b) whether the concerned, firm was handing those products without the authority and knowledge of IOC;
- (c) if; so, the steps contemplated for appropriate legal and preventive action; and
- (d) the details of compensation and financial assistance extended to the victims of the tragedy and to their families by IOC?

THE MINISTER OF STATE JN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) to (d) The information is being collected and will be laid on the Table of the House.

### Pending Proposals of Gas Agencies in Himachal Pradesh

- (a) whether some proposals to set up 22 Gas agencies in Himachal Pradesh are pending with the Ministry since March, 1995;
- (b) whether some other proposals to open 15 Gas Agencies in Himachal

Pradesh are pending with the Ministry since July, 1997;

- (c) whether Government have taken any decision on these proposals despite lapse of 45 months and 17 months respectively in the interest of development pf Himachal Pradesh; and
- (d) if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND GAS (SHRI SANTOSH NATURAL KUMAR GANGWAR): (a) to (d) Requests are received from time to time from different States of the country including Himachal Pradesh far setting up more LPG distributorships. The locations economically viable and feasible are included in the Marketing Plan for selection of LPG distributors through prescribed selection . procedure In Himachal Pradesh for ecofragile areas, Government has been allotting LPG distributorships and extension points direct to the Himachal Pradesh State Civil Supplies Corporation. Of the 37 locations recommended by Government of Himachal Pradesh, one location Kilar, Distt. Chamba has reportedly no motorable road and therefore, not feasible. All other locations are already having extansion points or are covered under the area of operation of existing LPG distributors; Of these, 15 locations have been found feasible and included in the. Marketing Plans for independent distributorships. Some of these locations have already been advertised.

## Non-Availability of Land for ONGC Projects in Gujarat

2751. SHRI RAJNATH SINGH 'SURYA: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) whether it is a fact that ONGC's projects to boost oil production have got bogged down due to land not being made available by the Gujarat Government;

- (b) if so, the reasons thereof; and
- (c) what steps Government are taking to get the project going?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR); (a) Two projects of ONGC for Enhanced Oil Recovery (EOR) at Balol and Santhal field in Gujarat have suffered some delay due to non-availlability of land for modification works.

- (b) The State Government has stopped acquisition of land on temporary basis which has been the practice till now and insist on acquistion of land on permanent basis.
- (c) Matter is being consistently pursued by ONGC with the State Government. The problem of land, acquisition has been taken up with the concerned State Government by the Ministry also.

#### Gas Cracker Unit at Tcngakhat

2752. SHRI A. VIJAYA RAGHAVAN: Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether it is a fact that due to shortage of Gas, the proposed Gas Cracker Unit at Tengakhat In Upper Assam will use Naptha;

THE MINISTER OF STATE, IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) and (c) The Government of India has committed to supply to the Assam Gas Cracker Project adequate natural gas required to produce 2 lakhs tonnes per annum of ethylene. For production beyond this level, Naptha may be used. Supply of Naptha to the extent available has been indicated from
