State Governments are extended financial assistance on 50% loan and 50% Grantsia-aid basis for procuring equipments, weaponry etc.

Employment Opportunities in North East

- 2710. SHRI ANANTRAY DE-VSHANKER DAVE: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) the details of Government plan to control insurgency in the North-Eastern Region in the near future;
- (b) whether employment opportunities are going to be created by Government to check unemployment among the youth;
 - (c) if so, the details thereof; and

THE MINISTER OF HOME AFFAIRS (SHRI L.K. ADVANI): (a) The Steps taken by the Central Government to curb insurgency include inter alia, deployment of additional units of Central Para Military Forces and the Army, improved coordination and sharing of intelligence, modernisation of State Police Forces, declaration of seriously affected area as disturbed areas and notification of major insurgent groups as unlawful associations.

(b) to (d) The National Agenda for Governance (NAG) streasses the need to re-appraise and revitalise reforms through giving primacy to removal of unemployment and give to the entire national development efforts a human face with total eradication of poverty and removal of unemployment. Recognising the right to work of every citizen, the main thrust will be "Berozgari Hatao" (eradicate unemployment). New investment and institutional thrust ot agriculture, the self employed, the unincorporated sector, infrastructure development and housing will act as the vehicles for massive employment creation at all levels.

The Central Government is also supplementing the efforts of the State Governments of North-East through Centrally sponsored special employment programmes viz. Integrated Rural Development Programme (IRDP), Jawahar Rozgar Yojana (JRY) and Employment Assurance Scheme (EAS).
