unutilised is infact earmarked for future utilisation for various purposes such as expansion and meeting the green belt stipulation laid down.

Based on the request of Govt, of Andhra Pradesh and after consultations with the State Govt, of Andhra Pradesh and Rashtriya Ispat Nigam Ltd. (Visakhapatnam Steel Plant), a decision has been taken to transfer 1100 acres of land for the purpose of development of a minor port at Gangavaram. This is subject to certain conditions including inter-alia making available alternate land to RINL on 'land to land' basis.

Fulfilment of Export Commitments made by Companies

*20. SHRI PRAFULL GORADIA: will the Minister of COMMERCE be pleased to state:

(a) the procedure followed by Government to ensure that export do take place as per the commitments made by the companies while applying for foreign collaboration;

(b) the details of the companies which failed in their export commitment during the last five years, year-wise; and

(c) the action taken by Government in this regard?

THE MINISTER OF COMMERCE (SHRI RAMAKRISHNA HEGDE): (a)The procedure prescribed for this purpose, requires the exporters to file Legal Undertakings binding themselves to fulfil the prescribed export commitments.

(b) The companies are required to fulfil export commitments undertaken by them at the time of seeking Foreign Collaboration over a period of time. The companies which do not fulfil these commitments are considered as defaulters. So far, 41 companies as per the enclosed list in the statement have been declared as defaulters. (*See* below)

(c) All these cases are under adjudication for imposition of appropriate penalities.
