(घ) सिंचाई परियोजनाओं की आयोजना, वित पोषण और उनका निष्पपादन राज्य सरकारों द्वारा उनके अपने संसाधनों से किया जाता है। ऐसी परियोजनाएं जिनका निर्माण वर्ष 1997-98 में शुरू किया जाएगा वे उत्तर प्रदेश की राज्य सरकार द्वारा उनको दी गई प्राथमिकता पर निर्भर होंगी।

## Ground water level in Maharashtra

- 154. MISS SAROJ KHAPARDE: Will the Minister of WATER RESOURCES be pleased to state:
- (a) whether Government are aware that the ground water level in Maharashtra particularly in its urban areas has decreased to such an extent that handpumps have become inoperative;
  - (b) if so, the details thereof; and

(c) whether any schemes have been prepared by Government to maintain the normal lavel of ground water in various parts of the State?

THE MINISTER OF STATE OF THE MINISTRY OF WATER RESOURCES (SHRI SIS RAM OLA): (a) and (b) Information is being collected.

(c) The Central Ground Water Board is carrying out experimental recharge studies in Amaravati and Jalgaon districts collaboration with the State Government under wheih percolation tanks, recharge shafts and injection wells have been constructed which have shown improvement in water availability and rise in ground water level. The statement government of Maharashtra is also carrying out ground water recharge and conservation ineasures under integrated watershed management scheme.

## Master Plan for Scientific water Management in Assam

- 155. SHRI PARAG CHALIHA: Will the Minister of WATER RESOURCES be pleased to state:
- (a) whether Brahmaputra Board has formulated any master plans for Scientific Water Management in Assam and other States of the North East Region:
- (b) if so, the details and status of each of these master plans; and
- (c) the steps taken to update expenditure and to mobilise resources for implementation of these master plans?

THE MINISTER OF STATE OF THE MINISTRY OF WATER RESOURCES (SHRI SIS RAM OLA): (a) Yes, Sir.

- (b) The Brahmaputra Board has drawn up Master Plan Part-I for the main stem of the Brahmaputra River, Master Plan Part-II for the river Barak and its tributaries and the Master Plan Part-III covering 38 tributaries of the river Brahmaputra and 8 rivers of Tripura. The Master Plan Part-I and Part-II has been approved by the Union Government. Other Master Plans were circulated to different concerned North Eastern States for their views and comments and on the basis of their comments, modifications of Master Plans have been taken up by the Board.
- (c) Updating of expenditure has not been taken up as the estimated amounts as derived against various items of the Master Plans are indicative. The exact expenditure to this effect will be worke out at the implementation stage.
