comments, modifications of master Plans have been taken up by the Board.

Master Plans prepared Brahmaputra Board suggested many viable long term and short term measures for flood management of North Estern Region by way of constructing moderate to high dams at upper reaches of major tributaries of Barak and Brahmaputra basin. The Brahmaputra Board has already identifed 13 such projects. Out which the De.ailed Project Reports for Pagladiva in Assam and Tipaimukh (Assam, Manipur, Mizoram border) have been prepared. Investigation for other projects have been taken up by the Board. The North Eastern Hydraulic and Allied Research Institute has been made operational during December, 1996, at a cost of Rs. 9.91 crore which will cater to various needs of multipurpose river valley projects of North East India.
