- (c) Andhra Pradesh, Gujarat, Karnata ka, Punjab, Tamil Nadu, Himachal Prad esh, Goa and Pondicherry have reported more than 90% coverage for all vaccina tions
- (d) the Immunisation Programme is implemented as part of the CSSM Prog ramme. Cash Assistance provided to States under CSSM Programme during 1997-98 is enclosed as Statement-II (See below). Assistance is also provided to States in kind, in the form of vaccines and cold chain equipment.

The various international donors are supporting the Pulse Polio Programme which are being held every year on 7th December and 18th January by providing special funds for vaccines/equipments support needed for the programme. During 1997-98 US \$ 43,408,600 have been committed by the various international agencies for Pulse Polio Programme.

Regular monitoring of the Programme is undertaken and where-ever any short fall in coverage is noticed, states are encouraged to make special efforts to improve coverage.
