The adjoining land to the south and west of the protect monument is under the control of the N.D.M.C. and is being used for holding demonstrations, public meetings etc. Archaeological Survey of India has taken up

the matter with Ministry of Urban Development for removing the jhuggi dwellers from the area.

THE MINISTER OF STATE IN THE DEPARTMENT OF EDUCATION IN THE MINISTRY OF HUMAN RE-SOURCE DEVELOPMENT (SHRI MUHI RAM SAIKIA): (a) to (c) In a communication, Member-Secretary of the Planning Commission has suggested a system of performancelinked funding of the Universities to improve quality of higher education. This suggestion is, infact, in line with the similar recommendations made by a Committee of the UGC appointed under the Chairmanship of Justice K. Pannayya. The Chairperson, UGC in her response, has broadly endorsed the idea. The details may, however, have to be worked out with reference to the provisions contained in the legislations governing the various Universities in the country.
